Supplied by the technical committee:

1. Reference materials: SkillsUSA Framework Materials and SkillsUSA Member Handbook.
2. One (1) blank 3" by 5" index card for preparation and to take into room
3. Copy of selected speech topic
4. Pencil or pen

Supplied by the competitors:

1. All competitors must create and submit a hard copy one-page single sided resume and include your competitor ID number at the top.

Competition Outline

- The technical committee will select a speech topic based upon material in the SkillsUSA Framework Fundamentals and SkillsUSA Member Handbook. All competitors will be assigned the same topic.
- Competitors will enter the preparation area, where they will be given the topic.
- Competitors will have five (5) minutes to develop and organize the content of their speech.
- During preparation time, competitors may consult reference materials supplied in the preparation area and may make notes on 3" by 5" card for use during the speech.



Competitors may not take any outlines, notes, or reference materials into the preparation area.

- The speech should be between three (3) and five (5) minutes.
- Timing starts when the presentation begins.
 - The timekeeper will signal the speaker at three (3) minutes, four (4) minutes and five (5) minutes. A penalty of five (5) points will be deducted for each 10 seconds or fraction thereof under three (3) minutes, or for each 10 seconds or fraction thereof over five (5) minutes.
- Competitors are permitted to use a watch or clock.
